I. CALL TO ORDER/ROLL CALL/PLEDGE OF ALLEGIANCE

The Board of Port Commissioners held its regular meeting in person at the Port Administrative Offices and via video/teleconference, pursuant to Government Code Section 54953(e). Members of the public participated in the meeting as well as remotely via the Zoom platform or in person at the Port Administrative Offices. Pursuant to the Ralph M. Brown Act, all votes were by roll call and the meeting was available to the public to attend and provide public comments via audio/video teleconference.

Chair Kastrop called the meeting to order at 8:00 AM. Clerk of the Board Linda Alvarado conducted roll call and confirmed a meeting quorum with Commissioners Claire, Garcia, Radcliffe, Maupin and Kastrop in attendance. Commissioner Garcia, Kastrop and Claire led the Pledge of Allegiance.

VIII. REPORTS/PRESENTATIONS

A. RECOGNITION OF FINAL MEETING OF OUTGOING COMMISSIONERS CLAIRE, GARCIA, AND KASTROP

Executive Director Zortman stated today is bittersweet as the Port is recognizing three Commissioners that are leaving. Executive Director Zortman stated on August 26, 2024 the City of Redwood City Council (City) will formally recognize Commissioners Claire, Garcia and Kastrop with a Proclamation and Resolution for their service. On August 28, 2024 the Port will also do the same. Executive Director Zortman stated she started her employment with the Port six years ago and expressed it has been an honor to work with each one of the outgoing Commissioners, citing how appreciative she is on their leadership and support. She stated that the Commission had taken a leap of faith when they hired her and she recognized the large hurdle to prove herself to Commissioner Claire. She thanked Commissioner Claire as he was sitting Chair through the global pandemic, stating how appreciative she is for his guidance and support, and for mentoring and educating her on the history of the Port and the relationship with the City. She stated Commissioner Garcia executed a lot of great things as sitting Chair such as launching public art. She also recognized Commissioner Kastrop for her leadership during Director Zortman's first year at the Port. She concluded with a presenting Commissioners Claire, Garcia and Kastrop with an inscribed desk clock detailing their years of service as Port Commissioners.

Commissioner Radcliffe stated the delight she has working with the outgoing Commissioners, acknowledging she has known each of the outgoing Commissioners for quite a long time. She also stated that it has been delightful to have worked together in the past, present and she knows that they will in the future. She recalled the vision and fun that she and Commissioner Claire had when they both served together in a past committee and organized the Walk About Downtown. She also stated how great it is to see so many things come to fruition. Commissioner Radcliffe recalled her time she and Commissioner Garcia served on the Planning Commission. She concluded by stating that serving with each of them has been great and thanked the outgoing Commissioners.

Commissioner Maupin highlighted Commissioner Claire's 17-year tenure as Port Commissioner. Also noting Commissioner Claire's remarkable history of serving 21-years on the Redwood City Council, including four years as Redwood City Mayor and seven years on Planning Commission. He also thanked Commissioner Claire's fiduciary oversight of the Port's finance and budget. He also noted Commissioner Claire served as Chairman of the Board for first ever Strategic Vision for the Port. Commissioner Maupin highlighted Commissioner Garcia's 19-year tenure on the Port Commission. He also stated that Commissioner Garcia is known for having more than 40-years of business experience in Redwood City and also serving on the Redwood City Planning Commission for ten years. He also noted Commissioner Garcia has been a value to the City as a local business owner/community leader and over 40-years serving the Optimist Club. Commissioner Maupin stated Commissioner Garcia served as Chairman of the Board when Port launched its first drone show. Commissioner Maupin highlighted Commissioner Kastrop's 16-year tenure as Port Commissioner, being the second woman to ever serve. Commissioner Maupin thanked Commissioners Claire, Garcia and Kastrop for their leadership and smooth transitions for both he and Commissioner Radcliffe.

Commissioner Claire stated he is thankful for the 44-years that he has served as a public servant, 17-years of those years as the Port Commissioner. Commissioner Claire stated that he is very pleased and it is a big win for the Port having Commissioners Maupin and Radcliffe on the Port Board. He also stated that the City has changed dramatically on his incredible journey. He concluded that while he did not vote for Executive Director Zortman six years ago, he is grateful that she was appointed.

Commissioner Garcia stated that it has been an honor to be a Port Commissioner, to participate in the great things that are happening at the Port. He stated that with Executive Director Zortman's leadership, the Port will always win. Commissioner Garcia stated that he will really miss serving as Port Commissioner and thanked everyone.

Commissioner Kastrop expressed her gratitude for the opportunity to serve the City and the Port for the past 16-years. She also stated that the Port is important to commerce and the growth of Silicon Valley and supports environmental benefits and emergency preparedness, it is a regional treasure. She also stated that it was a long-held dream of hers for the public to come to enjoy the waterfront, starting with PortFest—and now we have Rock the Dock, the Drone Show, on the working waterfront Port tours and more. She stated it makes her so happy to see the Port providing a fun experience for thousands of people of all ages from all over the region. She thanked each and every one of the Port staff, and the professionals-Francois Sorba, Port Attorney, Peter Friedman and Ray Bucheger, our representatives in DC, the Public Relations team Jenny Windle and JPW Communication and prior to that Duane Sandul. Sammy Lau and everyone else working behind the scenes to make sure the Port has the best opportunities to be successful. She also thanked Greg Greenway, Clem Molony and the Seaport Industrial Association, the Sequoia Yacht Club, the Marine Science Institute, Spinnaker Sailing, the Coast Guard Auxiliary, Sea Scouts and all of our tenants. She stated we have shared goals for mutual success and every organization at the Port is critical to that success. She thanked her fellow Commissioners, both now and in the past, since 2008: Larry Aikins, Dick Dodge, Dick Claire, Ralph Garcia, Tom Cronin, Simms Duncan, Stan Maupin and Nancy Radcliffe all working together for the good of the Port and the community. She thanked the incoming commissioners, Chu Chang, Michael Claire and Dani Gasparini, for taking their valuable time to devote to the Port and wished them all the best. She also thanked her husband Mike for his patience and understanding while she was away from the office on Port related matters. She stated her tremendous gratitude for the two Executive Directors that she worked with: Mike Giari and Kristine Zortman. She stated Giari welcomed her and was patient with her many ideas and projects, even when he wasn't totally in agreement. She stated how Executive Director Zortman took the ball and ran with it. She concluded stating "I know I'm leaving the Port with a great skipper, a great crew, and sailing on the right heading -thank you."

Executive Director Zortman expressed her gratitude for the years of service, support, leadership and relationships that were forged during their years of service. Don Snaman, Port contractor, expressed his gratitude to the outgoing Port Commissioners.

IX. EXECUTIVE DIRECTOR'S REPORT

Executive Director Zortman stated the 4th of July event hosted at the Port was a huge success. Port staff did a phenomenal job with preparation and clean up. On June 26, 2024 the Metropolitan Transportation Commission (MTC) approved a funding packet up to \$50 million, thanking the MTC Board, Commissioners Papan and Canepa. On July 19, 2024 Port staff and Chair Kastrop attended the San Francisco Bay Conservation and Development Commission (BCDC) Sediment and Beneficial Reuse Commissioner Working Group. On July 22, 2024 Port staff attended MTC's Regional Networking Management Council Meeting, citing the Port's future ferry terminal is not listed on their Plan Bay Area 2050+: Draft Project list. On July 22, 2024 the City of Redwood City Council passed the Business Tax License increase.

Chair Maupin called the meeting to order at 8:00 AM. Clerk of the Board Linda Alvarado conducted roll call and confirmed a meeting quorum with Commissioners Gasparini, Chang, Radcliffe and Maupin in attendance. Commissioner Gasparini led the Pledge of Allegiance.

II. PUBLIC COMMENT

Executive Director Zortman confirmed that there were no members of the public in attendance at the meeting who wished to make public comment on non-agendized items.

III. APPROVAL OF MINUTES — NONE

IV. APPROVAL OF CLAIMS — AUGUST 28, 2024

After inviting public comment, Chair Maupin confirmed with Executive Director Zortman that there were no members of the public who wished to make public comment on this agenda item. Chair Maupin recommended approval of claims dated August 28, 2024. A motion to approve minutes dated August 28, 2024, was made by Commissioner Radcliffe and was seconded by Commissioner Chang. The motion passed 4-0 with Commissioner Claire's absence by voice roll call vote.

VI. RESOLUTIONS

A. RESOLUTION OF THE BOARD OF PORT COMMISSIONERS OF THE CITY OF REDWOOD CITY APPROVING CONTRACT DOCUMENTS FOR THE PORT OF REDWOOD CITY MAINTENANCE DREDGING 2024 PROJECT AND AUTHORIZING AND DIRECTING ADVERTISEMENT FOR BIDS THEREFOR

Executive Director Zortman stated she would be excusing herself from item VI.A stating out of an abundance of caution due to potential conflict of interest. Executive Director Zortman introduced Christie Coats, Director of Operations, Don Snaman, Contractor for the Port and Scott Bodensteiner with Haley and Aldrich. Snaman stated Bodensteiner's familiarity on the project and is available to answer questions. Snaman presented projected plans of the dredge project area, as he detailed past uses and potential future use of the area. Snaman stated in addition to dredging Wharves 1, 2, 3 and 4 (Wharves), this dredging project is expanded to include dredging the Multi-Agency Maritime Facility (MAMF) and a future boatyard approach area. The MAMF project area is expanded to include the proposed Jet Dock facility to berth the Redwood City Police and Fire Department marine unit vessels. Snaman stated the dredging project will remove

sediments to -8' MLLW. Snaman stated the contract documents direct the contractor to dispose of the sediments complying with the limits set by the regulators based sampling and testing performed by Haley & Aldrich to address disposal of dredged sediments, with a goal of 20% of dredged sediment to be disposed in-Bay, a maximum of 40% disposed in the ocean, and a minimum of 40% disposed for upland beneficial reuse. Snaman concluded his presentation stating the Port's timeline entails a two-week bid window process and presentation of the lowest bidder shall be at the upcoming meeting. Commissioner Gasparini inquired as to who is responsible for bay and channel dredging. Director of Operations Coates stated the US Army Corps of Engineers is responsible for the ship channel dredging and the Port is responsible for keeping the berths dredged.

After inviting public comment, Chair Maupin confirmed with Christie Coats, Director of Operations, that there were no members of the public who wished to make public comment on this agenda item. A motion to adopt the resolution was made by Commissioner Radcliffe and was seconded by Commissioner Chang. The motion passed by a unanimous voice roll call vote of all Commissioners present.

Executive Director Zortman returned to the meeting following the motion passing on the floor.

VIII. REPORTS/PRESENTATIONS

A. FISCAL YEAR 2024 CARGO TONNAGE & UNAUDITED FINANCIAL REPORT ENDING JUNE 30, 2024

Executive Director Zortman introduced Rajesh Sewak, Director of Finance and Administration. Mr. Sewak stated there is a slight increase over last year's tonnage. Sewak stated for FY24 ending June 30, 2024, closed favorably with Operating Revenue at \$10.2 million, Operating Expenses at \$7.0 million and Non-Operating Income close to \$0.6 million leaving a Net Income of \$3.8 million. Sewak stated in detail the increase in cargo tonnage and property rental/leases, including new businesses, permitted the Port to sustain positive growth for FY24. Sewak stated employee costs, pensions and insurance rates are increasing, but with these additional increases the Port's budget remains healthy. This concluded his presentation on item number VIII.A.

B. RECEIVE THE CERTIFIED SEMI-ANNUAL INVESTMENT REPORT

Sewak, Director of Finance and Administration presented the Semi-Annual Investment Report. Sewak stated the Port maintains sufficient liquid resources, including maturities, are available to meet the cash flow needs for the next six months. Sewak stated all the securities in which Port funds, including all Trust Funds, are invested, excluding the deferred compensation plan and pension funds, which are invested separately. Stating all investments are in compliance with the Port's investment guidelines, with the exception of bank qualifications specified in the certificate of deposit requirements are not verified on each occasion a new certificate of deposit is purchased or rolled over. Sewak stated subvention to the City of Redwood City (City) is calculated after the audit is finalized. This concluded his presentation on item number VIII.B.

After inviting public comment for items VIII.A and VIII.B, Chair Maupin confirmed with Executive Director Zortman that there were no members of the public in attendance at the meeting who wished to make public comment on these agenda items.

IX. EXECUTIVE DIRECTOR'S REPORT

September 11, 2024 through September 13, 2024 staff will attend the California Marine Affairs & Navigation Conference (CMANC) 2024 Fall Meeting, including topics on latest insights and forecasts impacting port and harbors. On September 11, 204 staff will attend California Maritime Security Council Meeting hosted by U.S. Coast Guard. Executive Director Zortman stated September 15, 2024 will conclude this summer's successful pilot ferry trip to the Giants games. Executive Director Zortman announced the Port has been awarded the American Association of Port Authorities (AAPA) Lighthouse Award, for our Lunch and Learn series that the Port launched last year. Executive Director Zortman announced the well-received Lunch and Learn series are slated to recommence October 8, 2024. Executive Director Zortman thanked staff for the great job everyone is undertaking in gearing up for PortFest and recognized Trish Wagner for reinvigorating the sponsorship program, which has raised over \$10,000 this year. Executive Director Zortman concluded her report by thanking operations staff and office staff for the amazing job in keeping the Port running.

RECOMMENDATION

Staff recommends that the Board of Port Commissioners (Board) execute an agreement with The Dutra Group for the maintenance dredging of Wharves 1-4, Multi-Agency Maritime Facility (MAMF) and Boatyard Approach Area at the Port of Redwood City (Port).

BACKGROUND

On September 11, 2024 the Board approved the contract documents and solicitation of bids for the maintenance dredging of 34,231 cubic yards of sediments from Wharves 1-4 and 13,593 cubic yards of sediment from the MAMF and Boatyard Approach Area (Attachment A). Based on the Sampling and Analysis Results presented to and approved by Dredge Material and Management Office (DMMO) on September 18, 2024, all of the sediments could be disposed at the in-Bay disposal site adjacent to Alcatraz Island (SF-11), the deep ocean disposal site approximately 50-miles outside the Golden Gate (SF-DODS), or disposed for beneficial reuse at Cullinan Ranch Restoration Project (CRRP) and/or beneficially reused as cover material at the Montezuma Wetlands Restoration Project (MWRP). If sediment characterization is within limits for disposal at the different disposal sites, the Port's 10-year Integrated Alternatives Analysis (IAA) commits the Port to disposing a minimum of 40% of dredged sediments for beneficial reuse, a maximum of 40% at SF-DODS, and a maximum of 20% at SF-11, commonly referred to as 40/40/20.

The contract documents direct the contractor to dispose all the sediments from the MAMF and Boatyard Approach Area, 13,593 cubic yards, at MWRP and/or CRRP. To meet the IAA goals of 40% beneficial reuse of the total volume dredged, an additional minimum of 5,536 cubic yards from Wharves 1, 2, 3 & 4, for a total of 19,129 cubic yards, must be disposed at MWRP and/or CRRP. In addition, the contract documents state no more than 19,130 cubic yards, or 40% of the total volume, can be disposed at SF-DODS, and no more than 9,565 cubic yards, or 20% of the total volume, can be disposed at SF-11. The formatting of the proposal form allowed the bidder to potentially dispose of up to 100% of the sediments for beneficial reuse. Award of the contract is to the lowest responsible bidder.

ANALYSIS

On September 12, 2024 contract documents were provided to seven potentially interested dredging contractors. The contract documents were also posted on the Port's website and a Notice to Bidders was published in a local newspaper (Attachment B). On September 18, 2024, questions from bidders regarding the contract documents were due to the Port. On September 20, 2024 Addendum #1 was issued by the Port with responses to bidders questions (Attachment C). Due to the potential presence of rip rap within the dredge footprint of the MAMF and Boatyard Approach Area, a revised Sheet C-103 (Attachment D) was included that slightly revises the dredging footprint to not include any areas that may potentially contain rip rap. Any future work involving the rip rap, if necessary, will be done at a later date. In accordance with DMMO policy, Addendum #1 allows the contractor to dredge beyond the work window

Addendum #1 revised the completion date to December 31, 2024, provided the disposal occurs at CRRP and/or MWRP after November 30, 2024. Addendum #2 was issued on September 23, 2024 providing a regulatory permit (Attachment E). On September 25, 2024, proposal forms were due to the Port.

Bids were received from three qualified contractors (Attachment F), including one from the low bid contractor, The Dutra Group, for \$1,867,365.00. Two bidders, including The Dutra Group, propose to dispose of the sediments in accordance with the Port's minimum IAA requirements of 40/40/20. One bidder proposed to dispose of 80% of the sediments for beneficial reuse and 20% to SF-11. The Port's engineering consultant, Haley & Aldrich, has provided engineers estimates for the 40/40/20 proposed disposal option and the 80/20 disposal option (Attachment G). Haley & Aldrich have reviewed the bids for completeness and is recommending the Port award the contract to The Dutra Group (Attachment H). Staff has reviewed the status of the contractor's licenses, insurance and bond information, and references, finding all to be in good order. Additionally, Dutra has successfully completed the previous three berth maintenance dredging episodes in 2015, 2018, and 2021.

RECOMMENDATION

Staff recommends that the Board of Port Commissioners (Board) approve the contract documents for the Port of Redwood City Maintenance Dredging 2024 Project at the Port of Redwood City (Port) and authorize the solicitation of bids.

BACKGROUND

In 2021 the Port performed berth maintenance dredging at Wharves 1, 2, 3 & 4 to the design depth of -34′ MLLW. Nearly 30%, or 14,000 cubic yards, of the approximately 42,000 cubic yards of sediments were beneficially reused as cover material at the Montezuma Wetlands Restoration Project (MWRP) and the remainder of the sediments were disposed at the in-Bay disposal site adjacent to Alcatraz Island (SF-11) and the deep ocean disposal site approximately 50-miles outside the Golden Gate (SF-DODS). Recent soundings indicated that the berths had shoaled, reducing the controlling depth at Wharves 1, 2, 3 & 4 to approximately -32′ MLLW. Recently the U.S. Army Corps of Engineers awarded a contract to dredge the navigation channel to -30′ MLLW from the current controlling depth of -28′ MLLW, necessitating dredging of Wharves 1, 2, 3 & 4 to -34′ MLLW.

In addition to dredging Wharves 1, 2, 3 & 4, this dredging project is expanded to include dredging the Multi-Agency Maritime Facility (MAMF) and a Boatyard Approach Area. The current MAMF includes a one-lane launch ramp, boarding floats and gangway. The MAMF project area is expanded to include the proposed Jet Dock facility to berth the Redwood City Police and Fire Department marine unit vessels. The Boatyard Approach Area is adjacent to the warehouse and open space currently occupied under temporary permits with Assembly and IMI, respectively. The dredging project will remove sediments to -8' MLLW at the MAMF and to -20' at the Boatyard Approach Area.

On April 9 & 10, 2024, the Port's professional engineering consultant, Haley & Aldrich, Inc., collected sediment samples based upon the approved Sampling and Analysis Plan from the Dredge Material and Management Office (DMMO). Based on the sediment testing, disposal of the dredged sediments can be disposed at SF-11, SF-DODS and beneficially reused as cover material at MWRP and/or Cullinan Ranch Restoration Project (CRRP).

In addition to the sampling and testing, Haley & Aldrich prepared an Integrated Alternatives Analysis (IAA) to address disposal of dredged sediments in compliance with the limits set by the Long-Term Management Strategy (LTMS). The goal of LTMS is to significantly reduce the amount of dredged sediment disposed in San Francisco Bay, minimize disposal at SF-DODS, and maximize upland beneficial reuse. The current IAA and LTMS goals are for a maximum 20% of dredged sediment to be disposed in-Bay (SF-11), a maximum of 40% disposed at SF-DODs and a minimum of 40% disposed for upland beneficial reuse (20/40/40).

No. However, there may be an adjustment to the dredge quantities based on the pre-dredge survey. If so, those adjustments will need to comply with the 40/40/20 objectives in the original Proposal Forms.

3. Payment is based on pre-dredge and post-dredge surveys, but how will material be segregated or verified per each disposal line item? Will it be based on the estimated scow haul and then verified by survey, or something else?

Scow hauls will be used to estimate disposal site quantities. Payment will be based on difference between pre-dredge and post-dredge surveys.

4. Can the Contractor self-perform the pre-dredge and post-dredge surveys, or are they required to be conducted by a 3rd party?

The pre-dredge and post-dredge surveys will be performed by a licensed independent 3rd party hydrographic surveyor to be approved by the Engineer.

5. Can the Northing and Easting Coordinates be provided for the dredge footprint?

Yes, after Award of the Contract.

6. Please provide the report titled, "Results of Chemical, Physical and Biological Testing of Sediment form Wharves 1-4 at the Port of Redwood City.

7a. Please provide the Dredge Material Management Office's Suitability Determination.

DMMO approved the Sampling & Results Report on September 18, 2024. The Suitability Determination letter is forthcoming and a copy will be provided as soon as it is received by the Port.

7b. Please confirm all material from Wharves 1, 2, 3, 4, the MAMF, and the Boatyard Approach Area are suitable for disposal at the Montezuma Wetlands Restoration Project as "cover" material.

All dredged material is suitable for disposal at MWRP and CCRP as cover material.

8a. Has the Multi-Agency Maritime Facility (MAMF) been previously dredged to -8'+1' MLLW or is it entirely new work?

An area around the MAMF was previously dredged to -2' MLLW in approximately 1985. Additionally, shoreline protection may have been put in place between Wharf 4 and Wharf 5 at this time. Please see revised Sheet C-103 which revises the scope of work, identifying an area which should not be dredged from the toe of slope shoreward. No dredging should occur in any area of riprap.

8b. If the MAMF has been previously dredged, can the Port provide a post-dredge survey of the area?

There is no post-dredge survey of the area from ca. 1985.
8c. If the MAMF is new work, is there geotechnical boring data available? No.
8d. Has the Boatyard Approach Area been previously dredged to -20'+1' MLLW, or is it entirely new work? See response to Question 8a.
8e. If the Boatyard Approach Area has been previously dredged, can the Port provide a post-dredge survey of the area?
See response to Questions 8b.
8f. If the Boatyard Approach Area is new work, is there geotechnical boring data available? No.
9. Please provide the permit amendment for the MAMF and Boatyard Approach Area. If not available, when does the Port expect the amendment to be available?
We expect the amendments to be available by October 18, 2024.
10. Will the Port be responsible for ensuring all floating equipment is removed from the MAMF and Boatyard Approach Area to provide the contractor with unimpeded access to the dredge areas? Yes.
11. Can the Port clarify the number of homeowners' boats, where they are currently located, who is responsible for notification, the process if more than 5 days of relocation is required?
There are no homeowners' boats at the MAMF or the Boatyard Approach Area.
12. What is the expected regulatory approval period of the Dredge Operations Plan? Contractors should expect a 20-day regulatory approval period.
13. Can the Port provide an example of an expected berthing schedule?

Assume the following monthly ship calls:

Wharves 1 & 2 – 4 sand/aggregate ships at 1 day per call and 1 cement ship at 5 days per call.

Wharves 3 & 4 – 1 gypsum ship at 2 days per call and 1 scrap ship at 4 days per call.

The Port will provide a tentative vessel schedule upon contract award as well as weekly updates throughout the project timeline.

14. Please confirm whether other contractors and/or the Port's crew may be working adjacent to the site.

No other contractors or the Port's crew will be working adjacent to the site. However, bidders should be aware the U.S. Army Corps of Engineers is currently conducting maintenance dredging of the Redwood Creek Navigation Channel, portions of which are adjacent to the site.

15. Please confirm whether the Port will provide a lay-down area for Contractor's use during the course of work under this contract.

The Port will not provide a lay-down area. However, the Port will make available contractor parking and access to wharves or docks for crew changes.

16. Please confirm in the event of changes in laws or regulations taking effect after submission of Contractor's bid, Contractor shall be entitled to an equitable adjustment to the extent such change impacts Contractors' cost and/or time of performance.

Section 00210, Paragraph 7.01, Laws to be Observed, addresses changes in laws or regulations.

17. Please confirm and update the contract documents to reflect that in the event of delayed performance, liquidated damages will be assessed in lieu of actual/direct and consequential damages.

Liquidated damages are a waiver of consequential damages.

18. Please confirm whether this project is funded in whole or in part by the U.S. Government.

This project is not funded in whole or in part by the U.S. Government.

19. Please confirm Contractor is responsible only for hazardous materials brought to the Project site and/or generated by the Contractor and will not be responsible for any pre-existing materials containing substances classified as hazardous, potentially hazardous, infectious, toxic or dangerous under applicable law, which shall be disposed of in strict compliance with all regulations as directed by the Owner/Port. With respect to any such pre-existing materials, Owner/Port is the generator.

Section 00220, Paragraph 1.34 (Disposal of Material) addresses responsibilities for hazardous materials.

20. Please confirm that an equitable adjustment to the Contract Time, Price, or both will be granted in the event that the Port orders Contractor to suspend work for reasons not attributable to Contractor.

21. Please delete the language allowing the Port or its authorized representative to take possession of Contractor's materials, tools, and appliances from Section 8.09(B) of the General Conditions.

The Port's standard Section 8.09(B) of the General Conditions includes 'equipment', which has been deleted in the current contract documents.

22. Please confirm that Contractor is solely responsible for damage to known utilities and will not be responsible for damage to utilities not shown on the plans and specifications or identified by the local utility locator service.

Section 00210, Paragraph 10.02, Underground Obstructions, addresses unknown and unidentified utilities.

23. Unlike land-based construction, completed dredging activities are subject to natural forces that are entirely outside the control of the Contractor. To clarify the intent of the warranty, please include the following warranty provision: "The warranty provisions herein do not apply to the dredging portion(s) of the work. With respect to dredging, upon Contractor's advising Owner/Port that the dredging has been completed, Owner/Port shall inspect the Work and, if acceptable, shall advise Contractor of Owner's/Port's acceptance thereof. Contractor in no way represents, guarantees or warrants that any dredging or excavation will stay open, dredged or excavated for any period of time whatsoever."

The current contract documents contain the following warranty provisions: "Contractor does not in any way guarantee or warrant that any dredged or excavated area will remain at the dredged or excavated level for any period of time."

24. Please confirm that Contractor shall be entitled to an equitable adjustment to the Contract Time and/or Contract Price for delays caused by the negligent acts or omissions of the Owner/Port, other contractors employed by the Owner/Port, or anyone for whom the Owner/Port is responsible.

Section 00210, Paragraph 8.03, Delays, and Paragraph 8.04, Time Extensions, addresses adjustments to Contract Time and/or Contract Price due to delays.

25. Please confirm Contractor shall be entitled to an equitable adjustment in the Contract Time and/or Contract Price in the event Contractor encounters (a) subsurface or latent physical conditions at the site differing materially from those indicated in the Contract Documents or reference documents, or (b) unknown physical conditions of an unusual nature at the site differing materially from those ordinarily encountered and generally recognized as inherent in the work of the character provided for in the Contract.

27. "During the dredging, a steel grid "grizzly" with twelve-inch square maximum openings shall be placed over the hopper of the dump scow for material processing." A "grizzly" is required for all dredge disposal sites.

28. "Additionally, the Contractor shall be aware that under Section 2 of the CDFW Lake and Streambed Alteration Agreement (LSAA), a Biological Monitor shall be approved by CDFW and present during dredge operations." Please confirm if the contractor is to supply the biological monitor.



This Streambed Alteration Agreement (Agreement) is entered into between the California Department of Fish and Wildlife (CDFW) and the Port of Redwood City (Permittee) as represented by Don Snaman.

RECITALS

WHEREAS, pursuant to Fish and Game Code (FGC) section 1602, Permittee notified CDFW on June 9, 2015 that Permittee intends to complete the project described herein.

WHEREAS, pursuant to FGC section 1603, CDFW has determined that the project could substantially adversely affect existing fish or wildlife resources and has included measures in the Agreement necessary to protect those resources.

WHEREAS, Permittee has reviewed the Agreement and accepts its terms and conditions, including the measures to protect fish and wildlife resources.

NOW THEREFORE, Permittee agrees to complete the project in accordance with the Agreement.

PROJECT LOCATION

The Port of Redwood City Wharves 1-4 Maintenance Dredging Project (Project) is located at the Port of Redwood City Municipal Marina, located on the southeast bank of Redwood Creek adjacent to the federally maintained Redwood Creek Harbor deepwater ship channel near the confluence of Redwood Creek and Smith Slough, at 675 Seaport Boulevard, in the City of Redwood City, in the County of San Mateo, State of California; Latitude 37°30'45"N, Longitude 122°12'39"W.

PROJECT DESCRIPTION

Under this Agreement, Permittee will conduct "routine maintenance activities", defined as periodic activities necessary to maintain the ship berth depth of -34 feet Mean Lower Low Water (MLLW) plus one foot of allowable over-depth of Redwood Creek at the Port of Redwood City Berths 1 through 4. Approximately every two to three years, partial sediment will be dredged and disposed of either at the Alcatraz Dredged Material Disposal Site (SF-11) or the San Francisco Deep Ocean Disposal Site (SFDODS), and the remaining amount will be disposed of at an upland beneficial reuse site.

From 2015 through 2024, a total of three dredging events will occur, with a total maximum of 150,000 cubic yards (CY) removed. Fifty thousand CY of sediment will be removed during each of the three dredging events. The dredging footprint is 5.2 acres. A closed mechanical bucket will lift and place the sediment into a closed barge. The barge will be inspected prior to dredging and will be electronically monitored for leaks during the course of the Project.

Routine maintenance activities authorized under this Agreement are limited to the following:

Sediment Removal

— Utilizing large equipment for the removal of sediment within
Redwood Creek at ship berths 1-4 at the Port of Redwood City. No more than
50,000 CY of sediment per dredging event shall be removed, and only one
excavation event shall be conducted each year, and no more than three
dredging events shall occur during the term of this Agreement.

PROJECT IMPACTS

Existing fish or wildlife resources the Project could substantially adversely affect include: nearshore marine fish species such as green sturgeon (*Acipenser medirostris*), longfin smelt (*Spirinchus thaleichthys*), surfperch (Embiotocidae), topsmelt (*Atherinops affinis*), and rays and sharks; macroinvertebrates; Ridgeway's rail (*Rallus longirostris obsoletus*); and migratory, nesting and foraging waterfowl and other birds.

The adverse effects the Project could have on the fish or wildlife resources identified above, without implementation of the Measures to Protect Fish and Wildlife Resources specified below, include: change to and loss of natural bed substrate; direct take of fish and other aquatic species during Project activities; direct impacts from dredging on benthic organisms during Project activities; increase in turbidity during Project activities; reduction in water quality; introduction or spread of invasive aquatic species; and disruption to nesting and foraging waterfowl and other birds.

MEASURES TO PROTECT FISH AND WILDLIFE RESOURCES

1. Administrative Measures

Permittee shall meet each administrative requirement described below.

- 1.1 <u>Documentation at Project Site</u>. Permittee shall make the Agreement, any extensions and amendments to the Agreement, and all related notification materials and California Environmental Quality Act (CEQA) documents, readily available at the project site at all times and shall be presented to CDFW personnel, or personnel from another state, federal, or local agency upon request.
- 1.2 <u>Providing Agreement to Persons at Project Site</u>. Permittee shall provide copies of the Agreement and any extensions and amendments to the Agreement to all persons who will be working on the project at the project site on behalf of Permittee, including but not limited to contractors, subcontractors, inspectors, and monitors.
- 1.3 Notification of Conflicting Provisions. Permittee shall notify CDFW if Permittee determines or learns that a provision in the Agreement might conflict with a provision imposed on the project by another local, state, or federal agency. Permittee shall notify Suzanne DeLeón, at suzanne.deleon@wildlife.ca.gov, (831) 440-9433, or if unavailable, shall contact the CDFW Bay Delta Regional Office by mail, phone (707-944-5500) or fax (707-944-5553). In that event, CDFW shall contact Permittee to resolve any conflict.
- 1.4 <u>Project Site Entry</u>. Permittee agrees that CDFW personnel may enter the work site(s) at any time to inspect routine maintenance activities performed and to verify compliance with this Agreement.
- 1.5 Additional Measures. As a result of any field inspection, CDFW may require that additional measures be applied to specific activities to protect sensitive biological resources. Such measures may be amended into this Agreement with the agreement of both parties, or if an exception to authorized activities is identified, Permittee may be asked to submit separate written notification to CDFW pursuant to Condition 1.7. below.
- 1.6 <u>Authorized Routine Maintenance Activities</u>. Only those activities specifically described in the Project Description shall be conducted under this Agreement.
- 1.7 Exceptions to Authorized Activities. Permittee shall submit separate written notification (Forms FG 2023 and FG 2024) pursuant to

Section 1602 of the FGC, together with the required fee prescribed in the CDFW Streambed Alteration Agreement fee schedule, and otherwise follow the normal notification process prior to the commencement of work activities in all cases where one or more of the following conditions apply:

- The proposed work does not meet the criteria established for routine maintenance activities in the Project Description of this Agreement:
- The nature of the proposed work is substantially modified from the work described in the Project Description of this Agreement;
- CDFW advises Permittee that conditions affecting fish and wildlife resources have substantially changed at a specified work site or that such resources would be adversely affected by the proposed maintenance activity; and/or;
- The proposed work would adversely impact a State of California (State) Species of Special Concern or State or federally listed rare, threatened, endangered or candidate species or its habitat.
- 1.8 CDFW-Approved Qualified Biologist(s) and Biological Monitor(s). If biological monitors are required or surveys need to be conducted, Permittee shall submit to CDFW for approval, within a minimum of 30 days prior to initiating special-status surveys within the project area, the names and resumes of all biologists and biological monitors involved in conducting surveys and/or monitoring work.

A qualified biologist is an individual who shall have a minimum of five years of academic training and professional experience in biological sciences and related resource management activities with a minimum of two years conducting surveys for each species that may be present within the routine maintenance project area.

A biological monitor is an individual who shall have academic and professional experience in biological sciences and related resource management activities as it pertains to this project, experience with construction-level biological monitoring, be able to recognize species that may be present within the routine maintenance project area, and be familiar with the habits and behavior of those species.

1.9 <u>Unauthorized Take</u>. This Agreement does not authorize the take of any State or federally listed threatened species, endangered species, Species of Special Concern or candidate species. If CDFW determines, or Permittee finds, that there are such species on the

work site, Permittee shall notify CDFW and/or US Fish and Wildlife Service (USFWS), as appropriate. Permittee shall immediately cease work until CDFW and other applicable agencies deem that the concern over special status species has been resolved. This Agreement does not authorize capture and/or handling of listed species.

2. Avoidance and Minimization Measures

To avoid or minimize adverse impacts to fish and wildlife resources identified above, Permittee shall implement each measure listed below.

Work Periods

- 2.1 <u>Seasonal Work Period</u>. To avoid or minimize adverse impacts to fish and Ridgeway's rail and their habitats, work within the Project area shall be limited to the period of September 1 to November 30.
- 2.2 Completion by End of Seasonal Work Period. The sediment removal shall not be initiated unless there is a high likelihood that it can be completed before the end of the seasonal work window designated in Measure 2.1. After November 1 of each year, projects that have not been started or are still underway shall be evaluated to ensure they can be completed before the end of the seasonal work period. Those projects unlikely to be completed before the end of the seasonal work windows shall not be started.

Wildlife Protection Measures

- 2.3 Education Session before Commencement of Work. Prior to any project or construction activities, the biological monitor or qualified biologist shall conduct an education session on species that may be present at the project work site. The training shall consist of basic identification of the species, their basic habits, how they may be encountered in the work area, and procedures to follow when they are encountered. Any personnel joining the work crew later shall receive the same training before beginning work. The penalties for non-compliance of conditions in this Agreement shall be relayed to all project personnel.
- 2.4 <u>Access</u>. Access to the work site shall be via existing roads, boat ramps and boat docks.
- 2.5 <u>Designation of Work Area</u>. Permittee shall use buoys to identify the limits of the upstream and downstream dredging area. Dredging

- shall not occur outside the delineated area. All buoys shall be completely removed from the Project site and properly disposed of upon completion of Project activities.
- 2.6 Floating Dredge Equipment. The Permittee shall ensure that all equipment used during the dredging activities are located in areas where they will float during all stages of the tide. At no time shall dredging equipment be allowed to rest on the substrate during a low tide event.
- 2.7 <u>Containment of Material in Dredge Bucket</u>. The dredge bucket shall remain closed during hoisting and swinging action in order to avoid spillage and leakage of material from the bucket.
- 2.8 Barge Overflow Requirements. No overflow or decant water shall be discharged into the channel from the barge, with the exception of minor spillage (less than one gallon per hour) incidental to mechanical dredge operations. If excessive discharge from dredge spoils is discovered by any of the personnel on board the barge, activities shall cease until appropriate corrective measures have been completed and the discharge source has been repaired or halted. During transportation from the dredging site to the disposal site, no material shall be permitted to overflow, leak or spill from the barge, bins or dump scows.
- 2.9 <u>Dredged Materials</u>. All dredge materials shall be immediately transferred into a fully contained scow or suitable vessel. Runoff and or leakage from the transfer vessel shall be minimal.
- 2.10 <u>Turbidity Minimization Measures</u>. Permittee shall minimize the effects of turbidity outside permitted dredge limits by utilizing an environmental bucket or any other operational control(s), subject to CDFW approval.
- 2.11 <u>Protect Banks and Vegetation</u>. No disturbance to stream banks shall occur. Streamside vegetation overhanging into the channel shall not be removed, trimmed, or otherwise modified.
- 2.12 Nesting Habitat Removal or Modification. No trees, shrubs or wetland and marsh habitat shall be disturbed that contain active bird nests until all eggs have hatched, and young have fully fledged (are no longer being fed by the adults, and have completely left the nest site). No habitat removal or modification shall occur even if the nest continues to be active beyond the typical nesting season for the species (typically February 1 to August 31), until the young have fully fledged and will no longer be adversely affected by the project. If an

- active nest is found, the Permittee shall consult with CDFW and the USFWS regarding appropriate action to comply with the FGC of California and the Federal Migratory Bird Treaty Act of 1918.
- 2.13 Allow Wildlife To Leave Unharmed. Permittee shall allow any wildlife encountered during the course of Project activities to leave the Project area unharmed. All reasonable efforts shall be made to capture and move all stranded aquatic life observed in the removed material. Captured aquatic life shall be released immediately in the closest body of water adjacent to the Project site that will not be impacted by Project activities. This condition does not allow for the take or disturbance of any state or federally listed species, or state listed species of special concern.

Vegetation Removal

2.14 <u>Existing Vegetation</u>. No vegetation or trees shall be removed as part of the project.

Biological Monitors and Qualified Biologists

- 2.15 <u>Sensitive Species Sightings</u>. Any sightings of special-status plant, wildlife or aquatic species shall be reported to CDFW within 24 hours. If sighting was within the immediate Project area, all activities shall cease and Permittee shall confer with CDFW prior to resumption of activities. Through consultation with CDFW, additional measures may be developed to protect special-status species.
- 2.16 <u>Injury or Mortality of Special-Status Species.</u> If Permittee or its employees, contractors, or agents injures or kills a special-status species, or finds any such animal injured or dead, all activities in the work area shall immediately cease, and CDFW and USFWS shall be notified by telephone within 30 minutes of the discovery. A written report detailing the time, location, and general circumstances under which the dead or injured individual animal was found shall be submitted to CDFW and the USFWS no later than five (5) business days following the incident.
- 2.17 <u>Stop Work Authority</u>. The biological monitor or qualified biologist shall have the responsibility and authority of stopping the project if any crews or personnel are not complying with the provisions outlined in this Agreement.
- 2.18 <u>Change of Conditions</u>. If, in the opinion of CDFW, conditions arise, or change, in such a manner as to be considered deleterious to the

stream or wildlife, operations shall cease until corrective measures approved by CDFW are taken.

Routine Maintenance Limits

- 2.19 <u>Limits on Sediment Removal</u>. Sediment removal shall be limited to the amounts and timing specified in the Project Description. Specifically, sediment removal shall be limited to 50,000 CY for each sediment removal event. Sediment removal shall be limited to three times within the Years 2015 through 2014 for a total of 150,000 CY.
- 2.20 Stockpiling of Soil. No castings or spoils shall be placed on the stream side of the bank or levee where it could enter the stream or cover riparian or wetland areas.

Equipment and Vehicles

- 2.21 <u>Vehicle/Equipment Maintenance</u>. Any equipment or vehicles driven and/or operated in proximity of the stream shall be maintained in good working order to prevent the release of contaminants that if introduced to water could be deleterious to aquatic life, wildlife, or riparian habitat. Vehicles shall be moved away at least 150 feet from the stream prior to refueling and lubrication.
- 2.22 Equipment Storage and Stationary Operation. Staging and storage areas for equipment, materials, fuels, lubricants and solvents shall be located outside of the stream channel and banks. Stationary equipment such as motors, pumps, generators, compressors and welders, located adjacent to the stream, shall be positioned over drip-pans. Any equipment or vehicles driven and/or operated in proximity to the stream must be checked and maintained daily.

Toxic or Hazardous Materials

2.23 Storage and Handling of Hazardous Materials. Any hazardous or toxic materials that could be deleterious to aquatic life shall be contained in watertight containers or removed from the project site. Such materials include, but are not limited to, debris soil, silt, bark, rubbish, creosote-treated wood, raw cement/concrete or washings thereof, asphalt, paint or other coating material, and oil or other petroleum products. These materials shall be prevented from contaminating the soil and/or entering the waters of the State. Any such materials, placed within or where they may enter a stream or lake, by Permittee or any party working under contract, or with permission of Permittee, shall be removed immediately. BMPs shall be employed to accomplish these requirements.

- 2.24 Removal of Trash and Debris. Permittee shall remove all raw construction materials and wastes from work sites following the completion of maintenance activities. Food-contaminated wastes generated during work shall be removed on a daily basis to avoid attracting predators to work sites. All temporary fences, barriers, and/or flagging shall be completely removed from work sites and properly disposed of upon completion of maintenance activities. Permittee or its contractors shall not dump any litter or construction debris within the riparian/stream zone.
- 2.25 Wash Water. Water containing mud, silt, or other pollutants from equipment washing or other activities, shall not be allowed to enter the stream or placed in locations that may be subjected to high storm flows.

Spills and Emergencies

2.26 Spill Cleanup and Containment. All activities performed in or near a stream shall have absorbent materials designated for spill containment and clean- up activities on-site for use in an accidental spill. The Permittee shall immediately notify the California Emergency Management Agency at 1-800-852-7550 and immediately initiate the clean-up activities. CDFW shall be notified by the Permittee and consulted regarding clean-up procedures.

3. Reporting Measures

Permittee shall meet each reporting requirement described below.

3.1 Notification of Proposed Activities. Permittee shall provide CDFW written notification of proposed routine maintenance activities to be performed in the upcoming year by July 15 each year with the exception of Year 2015. Notification for 2015 shall be provided by September 28, 2015. Notification reports shall describe the project location, length and width of impact area, and a detailed description of proposed modifications to the channel. Reports shall be submitted to CDFW regardless of whether work is proposed.

CDFW shall append annual notification reports of proposed maintenance activities to this Agreement. For streamlined tracking, Permittee shall label annual notification reports according to the following convention: Exhibit A-[year] (e.g. Exhibit A-2015, Exhibit A-2016).

- 3.2 Annual Reports for Completed Projects. On an annual basis, Permittee shall provide CDFW written notification of maintenance projects completed. Annual reports shall include a brief project description, amount of sediment removed and the appropriate fee from the current CDFW Streambed Alteration Agreement Fee Schedule for work completed under this Agreement based upon the number of projects completed in the reporting period. The annual report is due on December 15 of each year. A report shall be submitted to CDFW regardless of whether work was completed. CDFW may terminate this Agreement if reports and fees are not submitted by this deadline.
- 3.3 <u>Four-year Status Report</u>. The Permittee shall provide a status report to CDFW every four years (2018 and 2022). The status report shall be delivered to CDFW no later than December 31 of each four-year period, and shall include all of the following information:
 - a) A copy of the original Agreement.
 - b) The status of the activities covered by the Agreement.
 - c) An evaluation of the success or failure of the measures in the Agreement to protect the fish and wildlife resources that the activity may have substantially adversely affected.
 - d) A discussion of any factors that could increase the predicted adverse impacts on fish and wildlife resources, and a description of the resources that may be adversely affected.

CDFW shall review the four-year status report, and conduct an onsite inspection to confirm that the Permittee is in compliance with the Agreement and that the measures in the Agreement continue to protect fish and wildlife resources. If CDFW determines that the measures in the Agreement no longer protect the fish and wildlife resources that may be substantially adversely affected by the activity, CDFW, in consultation with the Permittee, and within 45 days of receipt of the report, shall impose one or more new measures to protect the fish and wildlife resources affected by the activity. If requested to do so by the Permittee, CDFW shall make available the information upon which it determined the Agreement no longer protects the affected fish and wildlife resources

3.4 Notification to the California Natural Diversity Database (CNDDB). If any listed, rare, or special status species are detected during project surveys or on or around the project site during project activities, the Permittee shall submit CNDDB Field Survey Forms to CDFW in the manner described at the CNDDB website

LIABILITY

This Agreement does not constitute CDFW's endorsement of, or require Permittee to proceed with the project. The decision to proceed with the project is Permittee's alone.

SUSPENSION AND REVOCATION

Nothing in the Agreement limits or otherwise affects CDFW's enforcement authority or that of its enforcement personnel.

OTHER LEGAL OBLIGATIONS

This Agreement does not relieve Permittee or any person acting on behalf of Permittee, including its officers, employees, representatives, agents, or contractors and subcontractors, from obtaining any other permits or authorizations that might be required under other federal, state, or local laws or regulations before beginning the project or an activity related to it.

This Agreement does not relieve Permittee or any person acting on behalf of Permittee, including its officers, employees, representatives, agents, or contractors and subcontractors, from complying with other applicable statutes in the FGC including, but not limited to, FGC sections 2050 et seq. (threatened and endangered species), 3503 (bird nests and eggs), 3503.5 (birds of prey), 5650 (water pollution), 5652 (refuse disposal into water), 5901 (fish passage), 5937 (sufficient water for fish), and 5948 (obstruction of stream).

AMENDMENT

TRANSFER AND ASSIGNMENT

This Agreement may not be transferred or assigned to another entity, and any purported transfer or assignment of the Agreement to another entity shall not be valid or effective, unless the transfer or assignment is requested by Permittee in writing, as specified below, and thereafter CDFW approves the transfer or assignment in writing.

The transfer or assignment of the Agreement to another entity shall constitute a minor amendment, and therefore to request a transfer or assignment, Permittee shall submit to CDFW a completed CDFW "Request to Amend Lake or Streambed Alteration" form and include with the completed form payment of the minor amendment fee identified in CDFW's current fee schedule (see Cal. Code Regs., tit. 14, § 699.5).

EXTENSIONS

In accordance with FGC section 1605(b), Permittee may request one extension of the Agreement, provided the request is made prior to the expiration of the Agreement's term. To request an extension, Permittee shall submit to CDFW a completed CDFW "Request to Extend Lake or Streambed Alteration" form and include with the completed form payment of the extension fee identified in CDFW's current fee schedule (see Cal. Code Regs., tit. 14, § 699.5). CDFW shall process the extension request in accordance with FGC 1605(b) through (e).

If Permittee fails to submit a request to extend the Agreement prior to its expiration, Permittee must submit a new notification and notification fee before beginning or continuing the project the Agreement covers (Fish & G. Code, § 1605, subd. (f)).

EFFECTIVE DATE

The Agreement becomes effective on the date of CDFW's signature, which shall be: 1) after Permittee's signature; 2) after CDFW complies with all applicable requirements under the California Environmental Quality Act (CEQA); and 3) after payment of the



D. Will the proposed project required work in the wetted portion of the channel?

Yes, the project consists of dredging of sediment from the sea bed, at over 30 feet below MLLW. Therefore no water diversion would be required or implemented during this project.

Field 11 Project Impacts

C. Are any special status animals or plant species, or habitat that could support such species, known to be present on or near the project site?

Steelhead Trout: Dredging will only occur between June 1 and November 30 in compliance for the allowable work window established by the LTMS, unless permitted by NMFS and CDFW by consultation.

Longfin Smelt: A No-take Determination was submitted for the 2010 maintenance dredging project and approved by California Fish and Game. That document determined that this project will not affect longfin smelt or results in the incidental take of any longfin smelt individuals due to the project location in the south bay and occurrence in the fall.

The dredging area is over 500 feet from the nearest wetland/marsh, Bair Island, which is located across Redwood Creek. The Federally maintained ship channel is between the berths and the marsh.
